Minority students' scholarship announcement

ACADEMIC YEAR 2020-21

Applications are invited through online from the candidates belonging to **Christian, Muslim, Sikh, Buddhist, Paris and Jain** for granting Scholarship under Merit cum Means Based Scholarship for the year 2020-21.

- Students studying in professional/Technical Courses (4 Years and above) can apply for this scholarship.
- Eligibility Criteria:
 - (i) 50% of marks in the Previous Year Examination
 - (ii) Annual income of the Parent/ Guardian should not exceed 2.50 lakhs
- Students enjoying / enjoyed First Graduate Fee concession from the State Government shall not be recommended for the award of Minorities Scholarship. Hence, Candidates falling under the above category need not apply for MAMO Scholarship.
- Interested and Eligible students studying in I– IV year may apply under Fresh category.
- Student(s) who have been awarded Fresh Scholarship in the Previous Year (2019-20) are alone eligible for the renewal of above scholarship. Those candidates shall come under the category of Renewal cases.
- Candidates applying under Fresh as well as Renewal category may log on to the website (www.scholarships.gov.in)
- After the completion of Online submission, each student has to take up the generated application as a hard copy. The hard copy should be duly signed by the candidate and the same is required to be submitted preferably by post / courier to the head of the institution along with the following enclosures.
