

- The Nodal Officer of the Anti-Ragging Cell shall receive the complaints of ragging either directly from the students / victim or from the rest of the Members / Flying Squad members or any other responsible person who has witnessed the incident occurring within the campus.
- Based on the complaint, a preliminary enquiry shall be conducted by the Nodal Officer and report required to be submitted before the committee for further detailed enquiry.
- The committee shall abide all the instructions and guidelines issued by the UGC & AICTE in this connection in order to curb the menace of ragging in this institution.
- A separate email ID ([ucea.antiraggingcell@gmail.com](mailto:ucea.antiraggingcell@gmail.com)) and contact number for Anti-Ragging cell shall be provided and same would be notified in the notice board / official website.
- At the time of commencement of each academic year, the nodal officer shall take necessary steps to make every senior student of the college (II/III/IV year) to execute an affidavit instructed by the Hon'ble supreme court of India. The agreement should be executed along with the signatures of the parents of the candidate.
- The committee would also look after the necessary measures for imparting the information to the students about the provision, which impose stringent penal action against the students committing the ragging activities.
- As and when required, the members of flying squad shall make frequent visits to the admin & hostel blocks to ensure Anti-Ragging free campus.
- The nodal officer shall conduct adequate number of awareness programmes to the senior level students about the menace of Ragging and its legal consequences.
- The office of the Deputy Superintendent of Police / Station House Officer Arni (Rural) & All Womens' Police Station shall be kept informed about the particulars of existing members and the contact numbers of Nodal Officer (Anti-Ragging Cell), periodically.
- No special allowance would be paid to the Members / Nodal Officer in addition to their pay.
